
Subject : Management of Slide up admission

Madam/Sir,

As per the decision of the Govt., the following instruction is to be strictly implimented to facilitate students those who are facing problems in the process of auto slide-up admission.

- o The Students who have slided up and not completed final admission in their destination Higher Secondary Schools are required to take admission in the destination Higher Secondary School before 04-10-2018 positively otherwise their virtual admission at the destination Higher Secondary School shall be cancelled on 5-10-2018 and the seat will be filled up by students on transfer ground from 5-10-2018 on the basis of merit only.
- o The students who are continuing at their previous HSS due to their ignorance, they are to be adjusted against the existing vacancy before 04-10-2018 otherwise their claim for admission shall be cancelled on 05-10-2018 and those seats will be filled up by students on transfer ground from 5-10-2018 on the basis of merit only.
- o In case there is no vacancy in previously admitted Higher Secondary School, the principals of the H.S.S. concerned are required to admit them against equally created seats for the session 2018-19 only and a letter to this effect be submitted to DHSE immediately for post facto approval of the Govt.
- o The entire process of slide up admission shall be completed before 07-10-2018 to facilitate the HSS to submit Return of Matriculate (ROM) to CHSE in schedule time without fine.
- o All the Principals are requested to display the above instruction on the students Notice Board/College Notice Board and accordingly the students must be timely informed to avoid further critical issues in the process of slide up admission.


