Sub: Refund of admission fees to the students taking CLC under the Project Student Academic Management System (SAMS).

Madam/Sir,

With reference to the subject cited, I am directed to say that Govt. have received some complaints that some colleges are not refunding the admission fees to the students taking admission in upper choice colleges or with any reason or in other colleges from SAMS colleges to SAMS or Non-SAMS colleges. It has created discontent among the students and parents. Although Govt. has issued several letters to the colleges in this connection, some have not responded the orders properly.

Therefore, once again, it is requested to refund the fees deducting Rs100/- only from the total admission fees. The students those have taken CLC by the last date of admission into the +3 1st year classes (i.e. 31-08-2018) for the session 2018-19 will be eligible to get this benefit. In future, if any complain is received at this end, Govt. will be compelled to de-affiliate the SRC of those colleges from 2019-20. This supersedes all previous communications in the matter.
