Sub: 2nd Phase admission to the seats lying vacant in +3 Degree/Autonomous Colleges under SAMS for the session 2018-19.

Sir,

I am directed to say that 2nd Phase of admission to the seats lying vacant in +3 Degree/Autonomous Colleges (1st Year) shall be filled up through offline mode as per the following guidelines for Academic Session 2018-19.

Eligibility:

- A. The applicants who have passed the Instant Examination, 2018 conducted by CHSE (O).
- B. The applicants who could not apply during the normal application period (1st Phase of Admission i.e. 12/06/18 to 24/07/2018) due to various reasons.
- C. The applicants, those had applied earlier during 1st phase of admission, but not got any seats during online/offline admission.
- D. The applicants who are selected but could not take admission due to various reasons.
- E. The applicants who have already taken admission in normal admission period but want to switch over to other colleges.

Other Conditions:

1. Students can apply in offline mode at the college level.
2. Students will be admitted against the vacant seats in Honours/General on merit basis. No cut off mark condition will be applicable in this phase.
3. There will be reservation as per the rules in this phase. If there are no applicants, then the seats can be allotted to others.
4. The offline CAFs of all new applicants (eligible categories A&B) should be digitized before selection is made.
5. Selection will be made at the college level.
6. Students who have been slided up during 2nd round of admission but will not join by 29th July, 2018 in the higher preference college (Destination College), these seats can be treated as CLC taken and such vacant seats can also be filled up during 2nd Phase of admission. These students will have to take CLC from the destination college by depositing Rs 100/- only
